### ***Parent-Teacher Conferences – October 2020***


Scheduled updates on your child's progress.

### How is it revised?

### Who is it for?


All students participating in the Title I, Part A program, and their families are encouraged and invited to fully participate in the opportunities described in this plan. Pleasant Grove Elementary will provide the opportunity for the participation of parents and family members with limited English, disabilities, and of migratory children.

### Where is it available?

At the beginning of the year, the plan will be emailed to all parents. The Parent and Family Engagement Plan is posted on the school website. Parents can request a copy of the plan from their child's school.

## Curriculum

Parents can contact teachers throughout the year to access grade level standards, as well as core and supplemental curriculum. Title I Literacy Nights will address student achievement, standards, curriculum, and state and local assessments. At Teacher-Parent Conferences held in October, teachers will address the individual needs of students with parents, by providing up-to-date data reports and addressing mastery of grade level standards.



## Parent and Family Engagement

Pleasant Grove Elementary school believes that family engagement means the participation of parents and family members in regular two-way, and meaningful communication involving student academic learning and other school activities,

## Pleasant Grove Elementary is Branching Out!

Pleasant Grove Elementary will take the following measures to promote and support parents and family members as an important foundation of the school in order to strengthen the school and reach our school goals. We will:

- ✓ Ensure all information related to school and parent programs, meetings, and other activities is available in both English and Spanish and posted on the school website. Skyward, School Messenger, call-outs, event flyers and social media are also used for parent communication, in addition to the monthly school newsletter for all families.
- ✓ Provide trainings for staff with strategies to improve communication with parents and ideas to increase family engagement. Staff will also share best practices quarterly.
- ✓ Partner with early childhood programs, middle and high schools, college and career ready resources or organizations, or other programs (as applicable) to help prepare parents and their children for successful school transitioning.
- ✓ Share information in English and Spanish on the school website and in the school newsletter for parents to understand the school's academic standards and assessments as well as the ways parents can monitor their child's progress and work with educators.
- ✓ Communicate with all families and the community on a regular basis regarding schoolwide events and activities, through phone messages, social media, and flyers.
- ✓ Work with our parents to develop relevant trainings and helpful presentations to educate our staff on the importance of parent and family engagement and how to support student learning.
- ✓ Provide necessary materials and handouts for parents at conferences, meetings, and activities to help parents work with their child to improve their child's achievement.
  - ✓ Use our Parent and Family Engagement members, SAC and other partners in education to improve awareness of the activities and events listed in the school parent and family engagement policy.
  - ✓ Collect feedback from parents and family members at events, provide input cards, and parent surveys to support family engagement activities.

- ✓ A "Parent Right to Know" letter is sent home at the beginning of each school year to all students at the elementary and middle school level. This letter provides the right of parents to request the professional qualifications of their child's teacher. In the event a student is assigned a teacher that is "Out of Field" for four or more consecutive weeks the school will notify the parents through the school newsletter, school website, or a letter home.
